Sales are on a cash basis. In transactions where livestock are to be delivered at a later date, payment shall be in accordance with the contract. If purchases are not paid as specified, I will pay interest at the rate of _____ percent per annum (six percent if left blank) or highest rate allowed by law, whichever is lower, until paid in full. If the Market takes legal action to collect my account and prevails, the Market shall be entitled to reasonable attorney's fees and court costs.

I UNDERSTAND AND AGREE THAT THERE ARE NO IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE ON LIVESTOCK SOLD AT OR THROUGH THIS MARKET.

I hereby grant the Market a security interest in all livestock that I purchase at the Market, as well as all proceeds therefrom, until the Market has received final payment, and authorize the Market to authenticate and file any and all documents that are needed to perfect and give notice of the Market's interest in such livestock.

I hereby authorize Market or its agent Livestock Marketing Association to contact the above-named bank(s) for information concerning my financial responsibility and authorize the above-named bank(s) to release to Market or Livestock Marketing Association information necessary to determine my financial responsibility and/or ability to pay for livestock purchased at/through the Market. This authorization shall remain in effect until I notify the Market in writing that it has been cancelled. A copy of this authorization shall be as valid as the original.
